Running a red light violates Florida law and is *extremely dangerous*. Last year, nearly 900 people in the US died and more than 140,000 were injured as a result of collisions in which red light running was a factor. Florida is not immune to this risk.



It is this danger to our residents and visitors that prompted the City of Midway to adopt a photo enforced red light program. Recent studies have demonstrated conclusively that red light cameras save lives. At the conclusion of our "Warning" period, we will begin to issue Notices of Violations. If this had been a Notice of Violation, the civil penalty would have been \$158.00 (due within 30 days) and payment instructions would have been included with the Notice. Any violation NOT paid within 60 days WILL RESULT IN THE ISSUANCE OF A UTC by a uniformed traffic Officer which could affect your vehicle registration.

Remember, red light running is dangerous and illegal. When you disregard a traffic signal, you needlessly put yourself, your passengers and others at risk.
